#### BACKGROUND

In the New York Declaration on Refugees and Migrants of November 2016, States Parties committed to expanding opportunities for refugees and persons in need of international protection to enter a third country through safe and legal channels of entry, adhering to resettlement programmes and promoting complementary pathways to entry and protection. It further articulates the commitment to develop humanitarian pathways and increase opportunities for refugees to obtain study visas or access scholarships in EU Member States.

On 17 December 2018, the UN General Assembly endorsed the <u>Global Compact on Refugees</u> after two years of extensive consultations conducted by UNHCR with Member States, international organizations, refugees, civil society, the private sector and experts; one of the Compact's four macro-objectives is precisely to expand access to solutions in third countries by developing new pathways or strengthening existing ones.

Recently, according to the Commission Recommendation on legal pathways to protection in the EU (C(2020)6467 final), the link between community sponsorship and complementary pathways is a crucial nexus for improving refugee integration and significantly increasing refugee beneficiaries.

Finally, according to the latest UNHCR report, only 6% of refugees globally have access to **higher** education.

In this legal and political framework, since the 'long summer of migration' in 2015, <u>universities across the EU</u> started various refugee-related initiatives. Many contributed in the conventional way through research on topics like reception and integration. Some developed more practice-oriented solutions and opened their doors to forced migrants. Recognized refugees were given access to full-time study programs and asylum seekers were allowed to enroll in single

## TARGET AUDIENCE

Higher education institutions and university networks, associations, national authorities, international organisations, host communities, civil society organisations, volunteers and refugee students. university courses. In the majority of cases this was accompanied by softening rigorous intake procedures and removing financial barriers.

One example here is the Italian University Corridors for Refugees (UNICORE) project which in the last years has provided free access to a wide range of courses for hundreds of students with a refugee background. UNI.CO.RE began in Bologna in 2019 and has been expanding to 41 Italian Universities. In four years, therefore, the Italian universities have offered 150 study opportunities to refugee students abroad.

#### **OBJECTIVE**

Starting by the dissemination of the results of the evaluation on the Italian program UNICORE as deliverable of the EUPassworld project, this event will explore how the leadership of European universities can help expand the initiative and build new bridges for refugee students and scholars that will get the chance to access higher education and employment opportunities.

How could universities, or at least those who have already demonstrated their pledges to assisting refugee student and scholars, provide high-quality standards for their education pathway and afterwords?

Thus, the objectives of the event are to:

- Learn and discuss the current implementation of **existing "university corridors" programs** in Europe and beyond;
- Understand what and how legal and social drivers and barriers are currently impacting the implementation of this durable solution.
- Focus on the legal status main issues of foreign students and scholars who access university courses and study services;
- Explore opportunities for the **engagement of private sector** after the graduation, building also upon the **lessons learned** from universities experience.
